AN ORDINANCE AUTHORIZING THE VILLAGE MANAGER TO SELL THREE PROPERTIES

BE IT ORDAINED BY THE KINGDOM CITY BOARD OF TRUSTEES OF THE VILLAGE OF KINGDOM CITY, MISSOURI, AS FOLLOWS:
