LOCAL LAW NO. 5 OF THE YEAR 2024

Amending Section 65-5 and other Sections of the Lake Grove Village Code Regarding Fines and Penalties

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF LAKE GROVE AS FOLLOWS:

Section 1.0 Enactment.

- 1. Section 65-5 Certificate of Occupancy is hereby amended to read as follows:
 - "§ 65-5 Certificate of Occupancy.
- A. No person, corporation, firm, partnership, limited liability company, trust, trustee, estate, estate fiduciary or representative or other entity shall occupy or use any building or structure hereinafter erected or altered or enlarged, changed or altered, wholly or partly, in either its use or structure unless a certificate of occupancy is issued by the Building Inspector after he has determined that the conditions of the building permit have been complied with.
 - 2. Amendment of Section § 54-4 Penalties for Offenses
