Local Law 1 of the year 2023 (Introductory LL No. A-2023 )

## **A LOCAL LAW authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c**

Be it enacted by the Board of Trustees of the Inc. Village of Laurel Hollow, in the County of Nassau, as follows:

### **FIRST:**

#### **Section 1. Legislative Intent**

It is the intent of this local law to allow the Village of Laurel Hollow to adopt a budget for the fiscal year commencing June 1, 2023 that may require a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

#### **Section 2. Authority**

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

#### **Section 3. Tax Levy Limit Override**

The Board of Trustees of the Village of Laurel Hollow, County of Nassau is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2023 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

### **SECOND: Severability**

If any section, subsection, sentence, clause or phrase of this local law is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

### **THIRD: Effective Date**

This local law shall take effect immediately upon filing with the Secretary of State as provided by law.
