A LOCAL LAW AMENDING CHAPTER 140, WATERWAYS, BY ENACTING A NEW SECTION 140-12.1

Be it enacted by the Board of Trustees of the Inc. Village of Laurel Hollow, in the County of Nassau, as follows:

FIRST: The Code of the Inc. Village of Laurel Hollow is hereby amended to enact a new Section 140-12.1 thereof as follows:

Section 140-12.1 Fishing on the Laurel Hollow Beach

Fishing on the Laurel Hollow Beach is strictly prohibited from May 1 to September 30.

SECOND: Severability

If any section, subsection, sentence, clause or phrase of this local law is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this local law.

THIRD: Effective Date

This local law shall take effect immediately upon filing with the Secretary of State as provided by law.
