A LOCAL LAW authorizing a property tax levy in excess of the limit established in General M Law §3-c

Be it enacted by the Board of Trustees of the Inc. Village of Laurel Hollow, in the County of Nassau follows:

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Laurel Hollow to adopt a budget for the fiscal year commencing June may require a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vo percent (60%) of said governing body.

Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Laurel Hollow, County of Nassau is hereby authorized to adopt a budget for the fit commencing June 1, 2024 that requires a real property tax levy in excess of the amount otherwise prescribed in General §3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in while judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.
