

ORDINANCE NO. 2019-07

AN ORDINANCE OF THE TOWNSHIP OF LEET, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE MUNICIPAL GOVERNMENT HEREINAFTER SET FORTH DURING THE YEAR 2020.

BE IT ORDAINED AND ENACTED, that the Board of Commissioners of the Township of Leet, County of Allegheny, Commonwealth of Pennsylvania;

That for the expenditures and expenses of the fiscal year 2020, the following amounts are hereby appropriated from the fund equities, revenues and other financing sources available for the year 2020 for the specific purposes set forth.

ORDINANCE NO. 2019-07 A

AN ORDINANCE OF THE TOWNSHIP OF LEET, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2020.

Be it enacted, and it is hereby enacted by the Township of Leet, County of Allegheny, Commonwealth of Pennsylvania, that a tax be and the same is hereby levied on all real property within the Township of Leet subject to taxation for the fiscal year 2020.

Tax rate for general purposes, the sum of 7.7 mills
On each dollar of assessed valuation,
Or the sum of .77 cents
On each one hundred dollars of assessed valuation

That any ordinance or part of ordinance, conflicting with this ordinance be and the same is hereby repealed insofar as the same affects this ordinance.
