1513 Winans Avenue	1	On the northeasterly sideline of Winans Avenue, 94 feet more or less northwesterly from the projection of the northwesterly curbline of West 16 <sup>th</sup> Street in front of 1513 Winans Avenue for a length of 22 feet. The aforesaid space is specifically reserved and designated for a vehicle for Tammy Davis to be identified by license plate number and placard to be issued by the City, and no other vehicle bearing or displaying handicapped license plates and/or placards, or not, shall be permitted to park in such space.
315 Lincoln Street	1	On the southwesterly sideline of Lincoln Street, 28 feet more or less southeasterly from the projection of the southeasterly curbline of Hussa Street in front of 315 Lincoln Street for a length of 22 feet. The aforesaid space is specifically reserved and designated for a vehicle for Angela Rivera to be identified by license plate number and placard to be issued by the City, and no other vehicle bearing or displaying handicapped license plates and/or placards, or not, shall be permitted to park in such space.

Section 2. The remaining provisions of the Chapter hereby amended and supplemented shall continue in full force and effect to the same extent as if herein fully repeated.

Section 3. If any section, subsection, provision, clause, or portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction,

such adjudication shall not affect the remaining sections, subsections, provisions, clauses, or portions, which shall be deemed severable therefrom.

Section 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 5. This Ordinance shall take effect in the manner provided by law.
