A RESOLUTION OF THE TOWNSHIP OF LOWER MAKEFIELD AUTHORIZING THE APPROVAL OF AN EASEMENT TERMINATION AND RELEASE AGREEMENT AS RELATED TO THE FORMER BRIGHT FARMS PREVIOUSLY GRANTED TO THE TOWNSHIP BY THE ADJACENT PROPERTY OWNER KNOWN AS THE MRG PARCEL

WHEREAS the Township of Lower Makefield was previously granted an access and utility easement over and through property owned by MRG Stony Hill, LP (known as the MRG parcel), identified as TMP# 20-016-036-001; and

WHEREAS, the access and utility easement was necessary for the operation of Bright Farms formerly located on property owned by the Township, identified as TMP#02-016-049; and

WHEREAS the Bright Farms vacated operations and use of the Township property and the Township no longer requires the access and utility easement previously granted across and through the MRG parcel; and

WHEREAS owner of the MRG parcel has executed and delivered an Easement
Termination and Release Agreement to be duly recorded to official remove the recording
and grant of the prior access and utility easement to the Township.

NOW, THEREFORE, BE IT RESOLVED that the Township of Lower Makefield, Bucks County, in accordance with the powers granted unto to it and in accordance with the Second Class Township Code, hereby authorizes the Easement Termination and Release Agreement, as attached hereto as Exhibit "A" and as delivered by the owner of the MRG parcel to officially terminate the previously granted and recorded access and utility easement to the Township; and

FURTHER RESOLVED, that the Township Manager and all other proper officers of the Township are authorized and directed to take all steps necessary to carry out the purposes of this Resolution.

EASEMENT TERMINATION AND RELEASE AGREEMENT

THIS EASEMENT TERMINATION AND RELEASE AGREEMENT (this "Easement Termination and Release Agreement") is made as of the ____ day of ____ 2023, by and between Lower Makefield Township (hereinafter "LMT"), a Township of the Second Class, with its principal place of business being located at 1100 Edgewood Road, Yardley, Pennsylvania, 19067, and MRG Stony Hill, LP (hereinafter "MRG"), a Pennsylvania limited partnership, with an address of 25 South Main Street, #51, Yardley, PA 19067.

WHEREAS, LMT is the owner of certain real property more particularly described in Exhibit "A" attached hereto and also known as Tax Parcel No. 20-16-49. (the "LMT Parcel");

WHEREAS, MRG is the owner of certain real property more particularly described in Exhibit "B" attached hereto and also known as Tax Parcel No. 20-16-36-1 (the "MRG Parcel");

WHEREAS, on July 18, 2012 MRG and LMT entered into an Access and Utility Easement Agreement (the "Access and Utility Easement Agreement") which granted to LMT a "C" attached hereto (said 35 foot wide access and utility easement on the MRG Parcel, as more fully described in Exhibit as the "Greenhouse Easement");

WHEREAS, the Access and Utility Easement Agreement was recorded on July 20, 2012 in the Bucks County Recorder's Office as Instrument # 2012059369;

WHEREAS, the parties hereto do acknowledge there is no longer any need for the Greenhouse Easement, and therefore the parties have agreed to extinguish and terminate the easement in its entirety.

NOW, THEREFORE, in consideration of the sum of ONE DOLLARS (\$1.00) and other good and valuable considerations, the receipt of which is hereby acknowledged, and intending to be legally bound, LMT and MRG hereby agrees as follows:

1. The above recitals are hereby incorporated into this Easement Termination and Release Agreement.

- 3. Upon execution of this Easement Termination and Release Agreement, LMT and MRG further confirm that they are each relieved of any obligations they may have had, presently have or may have in the future under the Access and Utility Easement Agreement, which shall be extinguished of record.
- 4. This Easement Termination and Release Agreement inures to and binds the parties hereto and their respective successor and assigns.
- 5. This Easement Termination and Release Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original but all of which shall constitute one and the same Easement Termination and Release Agreement.
- 6. This Easement Termination and Release Agreement shall be duly recorded of record in the Office of the Bucks County Recorder of Deeds by MRG at its sole cost and expense.
