As authorized by Section 355.100 of this Code and when properly signposted, the following shall be handicapped parking spaces:

Location

1416 South Carolina Street.

Georgia Street, north side of the shoulder of the 300 block, beginning 50 feet from the middle of the intersection of 4th Street and Georgia Street and ending 70 feet from the middle of the intersection of 4th Street and Georgia Street.

Georgia Street (one (1) space), on the north side, beginning 20 feet and ending 40 feet from the easternmost portion of the intersection of Georgia Street and 6th Street. This handicapped parking space

will only be in effect Monday through Friday, 11 :OD A.M. to 1 :00 P.M.111

North 5th Street, on the West side of the 100 block, beginning 96 feet from the middle of the Georgia Street and 5th Street intersection and ending 116 feet from the middle of the Georgia Street and 5th Street intersection.

North 6th Street (two (2) spaces), on the east side, beginning 20 feet and ending 60 feet from the northernmost portion of the intersection of Georgia Street and 6th Street. These handicapped parking spaces will only be in effect Monday through Friday, 11 :DO A.M. to 1 :OD P.M. South 6th Street, on the east side of the 100 block, beginning 43 feet from the middle of the South Carolina Street and South 6th Street intersection and ending 63 feet from the middle of the South Carolina Street and South 6th Street intersection.

North Main Street, on the east side of the 100 block, beginning 43 feet from the middle of the Georgia Street and Main Street intersection and ending 63 feet from the middle of the Georgia Street and Main Street intersection.

North Main Street, on the east side of the 100 block, beginning 63 feet from the middle of the Georgia Street and Main Street intersection and ending 83 feet from the middle of the Georgia Street and Main Street intersection.

South Main Street, on the west side of the shoulder in the 200 Block, beginning 161 feet from the middle of the intersection of South Main Street and South Carolina Street and ending 256 feet from the middle of the intersection of South Main Street and South Carolina Street, in the City of Louisiana, Missouri.

South Carolina Street, north side, beginning 21 feet east of the east curb on Seventh Street, thence east 40 feet to the end.

South Carolina Street, north side, beginning 35 feet east of the east curb on Third Street, thence east 20 feet to the end.
