AN ORDINANCE TO AMEND CHAPTER 123 OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD ENTITLED "FEES" (Municipal Pool)

"Interpretive Statement" This Ordinance will establish the Municipal Pool rates for 2024

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that Chapter 123 of Code of the Township of Maplewood entitled "Fees" be amended to change the usage fees for the Maplewood Municipal Pool as follows:

<u>FIRST</u>: Chapter 193 Parks and Recreation Areas

- A. Article II, Maplewood Community Pool.
