- 1. Chapter 363 of the Code of the Township of Mansfield is hereby amended as follows [New language **bold and underlined**, deleted language **double strikethrough**]:
- Section 123-4 363-59 of the Code of the Township of Mansfield is hereby amended by adding to the list of prohibited uses, the following: "All classes of cannabis establishments or cannabis distributors or cannabis delivery services as said terms are defined in section 3 of P.L. 2021, c. 16, but not the delivery of cannabis items and related supplies by a delivery service."


