

**ORDINANCE NO. 2022-29**

**ORDINANCE OF THE TOWNSHIP OF MANSFIELD, COUNTY OF WARREN, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 49 "FIRST AID AND RESCUE SQUAD" TO DESIGNATE INDEPENDENCE FIRST AID SQUAD AS THE OFFICIAL EMERGENCY MEDICAL SQUAD OF THE TOWNSHIP**

**WHEREAS**, the Township Committee of the Township of Mansfield believes it to be in the best interest of the Township and its residents to designate the Independence First Aid Squad (Independence FAS) as the official emergency medical squad of the Township.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Mansfield, County of Warren, State of New Jersey, that Chapter 49 "First Aid and Rescue Squad" be amended and supplemented to designate Independence First Aid Squad as the official emergency medical squad of the Township as follows:

**SECTION 1:**

Additions to this Chapter shall be designated by underlined text. Deletions to this Chapter shall be designated by ~~strikethrough text~~.

**CHAPTER 49. FIRST AID AND RESCUE SQUAD.**

**§ 49-1. Recognition of Squad.**

~~Mansfield Emergency Medical Services, Inc.~~ Independence First Aid Squad is hereby recognized as a first aid, rescue or ambulance squad servicing the Township of Mansfield pursuant to the statutes of the State of New Jersey and shall be entitled to all benefits provided by the said statutes to a recognized municipal first aid, rescue or ambulance squad.

**§ 49-2. Instrumentality of Township.**

For purposes of N.J.S.A. 52:27D-126c, 54:27D-126(e), ~~Mansfield Emergency Medical Services, Inc.~~ Independence First Aid Squad shall be considered an agency and instrumentality of the Township of Mansfield.

**SECTION 2. Repealer.**

Any article, section, paragraph, subsection, clause, or other provision of the Code of the Township of Mansfield inconsistent with the provisions of this Ordinance is hereby repealed to the extent of such inconsistency.

**SECTION 3. Severability.**


The various parts, sections, and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section, or clause is adjudged to be unconstitutional or invalid by a court of competent jurisdiction the remainder of this Ordinance shall remain in full force and effect.

**SECTION 4. Effective Date.**

This Ordinance shall take effect upon final passage and publication as provided by law.
