AN ORDINANCE OF THE TOWNSHIP OF MANSFIELD, COUNTY OF WARREN, STATE OF NEW JERSEY TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF MANSFIELD, CHAPTER 206 "GAMES OF CHANCE"

STATEMENT OF PURPOSE

The purpose of this Ordinance is to authorize the Township Clerk as the issuing authority to approve raffle and bingo licenses to be held in the Township.

SECTION 1

Chapter 206, "Games of Chance" is hereby amended to ADD the following section:

Chapter 206, Section 2- Township Clerk Authorization

The Township Clerk is hereby authorized and delegated the authority to approve the granting of raffle and bingo licenses to be held in the Township of Mansfield.

SECTION 2

SEVERABILITY:

If any section, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION 3

REPEALER:

All ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.

SECTION 4

EFFECTIVE DATE:

This Ordinance shall become effective twenty (20) days following final adoption and publication as required by law.
