AN ORDINANCE IMPOSING A SALES TAX AT A RATE OF THREE PERCENT ON ALL TANGIBLE PERSONAL PROPERTY RETAIL SALES OF ADULT USE MARIJUANA SOLD WITHIN THE CITY OF MARYVILLE, MISSOURI, PURSUANT TO ARTICLE XIV, SECTION 2.6(5) OF THE MISSOURI CONSTITUTION SUBJECT TO THE APPROVAL BY THE VOTERS OF THE CITY AT THE GENERAL MUNICIPAL ELECTION TO BE HELD ON APRIL 4, 2023; DESIGNATING THE FORM OF BALLOT; AND DIRECTING THE CITY CLERK TO PROVIDE NOTICE OF SAID ELECTION.

WHEREAS, on November 8, 2022, the electors of the State of Missouri approved Amendment 3 to the Missouri Constitution enacting Section 2 of Article XIV of the Missouri Constitution effective December 8, 2022; and

WHEREAS, the newly enacted Article XIV, section 2.6(5) of the Missouri Constitution authorizes the City of Maryville, Missouri to impose, by ordinance, an additional sales tax in amount not to exceed three percent on all tangible personal property retail sales of adult use marijuana sold in such political subdivision subject to approval by voters of the City of Maryville, Missouri; and

WHEREAS, the City Council finds that it is in the best interests of the citizens of the City of Maryville, Missouri to impose a sales tax of three percent on all tangible personal property retail sales of adult use marijuana sold in the City of Maryville, Missouri and to submit the same to the voters of the City for approval by a majority of those voting at the general municipal election to be held on April 4, 2023.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF MARYVILLE, MISSOURI AS FOLLOWS:

<u>SECTION 1 – ADULT USE MARIJUANA SALES TAX</u>. A sales tax at the rate of three percent on all tangible personal property retail sales of adult use marijuana sold in the City of Maryville, Missouri, as authorized by Article XIV, section 2.6(5) of the Missouri Constitution, is hereby imposed. The tax imposed hereunder shall be in addition to any and all other sales taxes allowed by law.

<u>SECTION 2 – EFFECTIVE DATE</u>. The sales tax imposed by this Ordinance shall not be effective unless approved by a majority of the votes cast by the qualified voters voting thereon at the General Municipal Election to be held on April 4, 2023, at which election a proposal to authorize the City Council of the City of Maryville, Missouri, to impose the tax herein provided for shall be submitted to the voters of the City of Maryville.

<u>SECTION 3 – FORM OF BALLOT</u>. The ballot to be used in such election shall contain the following question:

<u>SECTION 4 – NOTICE OF ELECTION</u>. The City Clerk is hereby directed to notify the County Clerk of Nodaway County, Missouri, of the enactment of this Ordinance no later than 5:00 p.m. on Tuesday, January 24, 2023, in accordance with the Comprehensive Election Act, Chapter 115 of the Revised Statutes of Missouri, as amended. The form of the Notice of Election for said election, a copy of which is attached hereto and made a part hereof, is hereby approved.
