AN ORDINANCE PROVIDING FOR A GENERAL ELECTION TO BE HELD ON TUESDAY, APRIL 4, 2023, IN THE CITY OF MARYVILLE, MISSOURI, FOR THE PURPOSE OF ELECTING TWO (2) MEMBERS OF THE CITY COUNCIL, EACH FOR A THREE (3) YEAR TERM; DIRECTING THE CITY CLERK TO MAKE DUE NOTICE OF SUCH ELECTION AS PRESCRIBED BY LAW, TO THE COUNTY CLERK OF NODAWAY COUNTY, MISSOURI

WHEREAS, the City Council finds that there is to be elected, at the General Election, to be held on April 4, 2023, two (2) members of the City Council each to serve a three (3) year term, that due notice has been given to the qualified persons to file a Statement of Candidacy for such office; and,

SECTION 1: That the two (2) persons filing a Statement of Candidacy are Bryan Gerald Williams and Benjamin Lipiec, whose names shall appear on the ballot in the order in which they filed their Statement of Candidacy, which is as aforesaid.

SECTION 2: That the General Election of the City of Maryville, Missouri, shall be held on April 4, 2023, for the purpose of electing two (2) persons to serve as members of the Council of the City of Maryville, Missouri, each for a term of three (3) years.

SECTION 3: That the City Clerk of the City of Maryville, Missouri, is hereby directed to make due notice, as provided by law in regard to such election, to the County Clerk of Nodaway County by the tenth Tuesday preceding the General Election.

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage and adoption.
