#### ORDINANCE NO. 8098

## AN ORDINANCE ANNEXING CERTAIN REAL ESTATE, KNOWN AS SOUTH COUNTRY CLUB DRIVE, OWNED BY THE CITY OF MARYVILLE, MISSOURI

WHEREAS, there was presented to the City Council of the City of Maryville, Missouri, on the 23<sup>rd</sup> day of April, 2018 a verified petition, requesting voluntary annexation and signed by the owners of all the interest of record in all tracts of real property located within the area proposed for annexation, said area being situate in Nodaway County, State of Missouri; and,

WHEREAS, the City Council held a public hearing concerning said annexation on the 14<sup>th</sup> day of May, 2018, and caused notice of said hearing to be published in the Maryville Daily Forum on the 26<sup>th</sup> day of April 2018, said publications being evidenced by the publisher's Affidavits of Publication which are attached hereto as Exhibit "A" and made a part hereof by reference; and,

WHEREAS, at said public hearing, evidence regarding the proposed annexation was presented by the persons entitled to present such evidence; and

WHEREAS, written objection to the proposed annexation, representing at least five percent of the qualified voters of the City or two qualified voters of the area sought to be annexed if the same contains two qualified voters, was not filed with the City Council of Maryville, Missouri; and

WHEREAS, the City Council of Maryville, Missouri, hereby finds that the proposed annexation is reasonable and necessary to the proper development of the City and the City has the ability to furnish normal municipal services to the area to be annexed within a reasonable time.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARYVILLE, MISSOURI, as follows:

**SECTION 1**: The City limits of the City of Maryville, Missouri, are hereby extended to include the territory described above, the new boundary lines to which the corporate limits of the City of Maryville, Missouri, are now extended and incorporate the area being described as set out in attachment identified as "Exhibit B".

**SECTION 2**: That the Clerk of the City of Maryville, Missouri, is hereby authorized and directed to prepare three certified copies of this ordinance and to file said certified copies with the Clerk of the County of Nodaway, State of Missouri.

**SECTION 3**: That this Ordinance shall be in full force and effect from and after its passage and adoption.
