# AN ORDINANCE TO AMEND SECTION 405.040 (ZONING MAP), ORDINANCE NO. 4984 (ZONING ORDINANCE), FOR PROPERTY OWNED BY JASON BROWN AND ROXANNE POWELL TO CONFIRM ZONING OF SAID PROPERTIES AS R-2, SINGLE FAMILY RESIDENCE ZONE 

WHEREAS, on February 26, 2018, City Council approved the annexation of property owned by Jason Brown and Roxanne Powell, by Ordinance No. 8051, extending the city limits to include said property; and,

WHEREAS, said property was designated as R-2, Single Family Residence Zone in Polk Township; and,

WHEREAS, Section 405.060 .2 of the Maryville Municipal Code states that land shall remain subject to the zoning designation in effect prior to annexation until such time as the City adopts zoning regulation for the annexed property; and,

WHEREAS, on July 18, 2018, the Planning and Zoning Commission unanimously recommended confirmation of the property as R-2, Single Family Residence Zone.

# NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 

MARYVILLE, MISSOURI, as follows:
SECTION 1: The City Council of the City of Maryville, Missouri, confirms the designation of R-2, Single Family Residence Zone for the property annexed on February 26, 2018.

SECTION 2: Section 405.040 (Official Zoning Map), of Ordinance No. 4984, (Zoning Ordinance), be and the same is hereby amended by incorporating the following described properties as R-2, Single Family Residence Zone, to-wit:
