AN ORDINANCE AMENDING VARIOUS CHAPTERS RELATING TO THE SCHEDULING OF FEES
BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM, IN THE
COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

SECTION 1. The below listed Chapters scheduling various FEES are hereby amended as follows:

All ordinances of the Township of Mendham which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4.

This Ordinance shall take effect after final passage and publication pursuant to law.
