# ORDINANCE NO. 12-04-23 AN ORDINANCE VACATING PART OF FRONT STREET

WHEREAS, the City of Mendota, LaSalle County, Illinois wishes to vacate part of Front Street per the attached Exhibit "A"; and

WHEREAS, the Notice of said proposed vacation was published in the Mendota Reporter for more than 15 days prior to this hearing; and

WHEREAS, 65ILCS 5/11-91-1 (Public Act 90-179) give the municipality the convey title to a portion of the street being vacated to the adjoining owners east of said vacation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Mendota as follows:

- 1. It is in the best interest of the City of Mendota that the aforementioned portion of the street legally described in Exhibit 'A' be vacated, subject to the following:
  - a. The aforementioned east 40 foot portion of Front Street shall be vacated with title vesting the owners to the property immediately to the east of the portion of the street being vacated.
  - b. The City retains the right to maintain, operate, repair and replace by itself or by any licensee any poles, wires, pipes, conduits, sewer mains, water mains, drainage easements, or any other facility or equipment for the maintenance and operation of any utility now located in the street or portion thereof vacated by this Ordinance.
  - The Parcels acquiring the vacated street are: 01-33-230-013; 01-33-230-003; 01-33-230-010; and 01-33-230-005.

This Ordinance shall be in full force and effect after its passage and approval according to Illinois law.

# Parcel 1
