AN ORDINANCE TO AMEND CHAPTER 45: BUSINESS LICENSES, IN THE TOWN OF MIDDLETOWN CODE OF ORDINANCES

BE IT ENACTED BY THE MAYOR AND COUNCIL OF THE TOWN OF MIDDLETOWN (a majority of the members elected thereto concurring therein):

Section 1. That the Town of Middletown, Delaware, Code of Ordinances, Chapter 45: BUSINESS LICENSES, is hereby amended as follows:

- 1. Amend §45-14 by deleting "ten percent" and replacing with "one percent (1%)".
- 2. Amend CHART A: RATE SCHEDULE by changing the Resident Minimum Rate for Rate Class 6 from "\$6.00 (Per Space)" to "\$5.00 (Per Space)".
- 3. Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by adding NAICS Sector/Subsector "7211"; Industry Sector "Travel Accommodations"; Class "6"; Fee (Resident) "\$5.00 (Per Space)".
- 4. Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by removing Industry Sector "Hospitals" completely from the chart.
- 5. Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by removing Industry Sector "Natural Gas Distribution, Electric Power Generation, Transmission and Distribution" completely from the chart.
- Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by changing Industry Sector Accommodation and Food Services from Class "1" to Class "Gross Receipts".
- 7. Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by changing Industry Sector Wholesale Trade from Class "1" to Class "Gross Receipts".
- 8. Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by changing Industry Sector Healthcare and Social Assistance from Class "2" to Class "3".
- Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by changing Industry Sector Nursing and Residential Care Facilities from Class "1" to Class "3".
- 10. Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by removing NAICS Sector/Subsectors 812111 and 812112 and replacing them with:

- a. NAICS Sector/Subsector of "8121"; Industry Sector "Personal Care Services (2 or fewer)"; Class "1"; Fee (Resident) "\$125" and,
- b. NAICS Sector/Subsector of "8121"; Industry Sector "Personal Care Services (3 or more)"; Class "5"; Fee (Resident) "\$250".
- 11. Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by adding NAICS Sector/Subsector "48-49"; Industry Sector "Transportation and Warehousing"; Class "1"; Fee (Resident) "\$125".
- Amend CHART B: BUSINESS LICENSE CLASS SCHEDULE BY NAICS CODE by adding NAICS Sector/Subsector "4931"; Industry Sector "Warehousing and Storage"; Class "Gross Receipts"; Fee (Resident) "Sect. 45-21".

Section 2. This Ordinance shall become effective immediately upon passage.
