Ordinance No. 15-2024

AN ORDINANCE AMENDING MILLVILLE CODE CHAPTER 11 ("BUREAU OF PERMITS AND INSPECTIONS"), ARTICLE I ("ADMINISTRATION"), SECTION 11-1 ("CREATION OF BUREAU") IN ORDER TO CLARIFY THE SCOPE OF THE CONSTRUCTION OFFICIALS SUPERVISORY DUTIES

WHEREAS, existing Millville Code Section 11-1 ("Creation of Bureau") provides that the Construction Official shall be the supervisor in charge of "the subcode officials and inspectors"; and

WHEREAS, there is some confusion as to whether the term "inspectors" includes housing inspectors or other non-construction subcode officials; and

WHEREAS, it has always been the intent of the current Board of Commissioners that the scope of the Construction Official's supervisory duties be limited to the supervision of the construction subcode officials of the City; and

WHEREAS, the Board of Commissioners nevertheless finds that Code Section 11-1 needs to be amended to clarify the intent of the Board of Commissioners.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MILLVILLE that Millville Code Section 11 ("Bureau of permits and inspections"), Article I ("Administration"), Section 11-1 ("Creation of Bureau") is hereby amended as follows:

Section One

§11-1. Creation of Bureau.

The Bureau of Permits and Inspections is hereby created. The Construction Official shall be the supervisor in charge of all construction subcode officials and any other City employee who may be assigned to the Construction Official by the Director of Public Affairs or the business manager of his Department.

Section Two

Should any provisions of this ordinance be deemed invalid for any reason that invalidity shall not affect the remaining provisions of the ordinance, and the provisions and sections of the ordinance are hereby declared to be severable with respect to their validity.

This ordinance shall take effect twenty (20) days after final passage, according to law.
