

**CAPITAL ORDINANCE PROVIDING FOR THE PURCHASE OF A NEW ROLL-OFF TRUCK AND RELATED EQUIPMENT BY THE CITY OF MILLVILLE, IN THE COUNTY OF CUMBERLAND, NEW JERSEY AND APPROPRIATING \$253,000 THEREFORE**

**BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MILLVILLE, IN THE COUNTY OF CUMBERLAND, NEW JERSEY AS FOLLOWS:**

**SECTION 1.**

The improvements described in Section 2 of this ordinance are hereby authorized to be undertaken by the City of Millville, County of Cumberland, State of New Jersey, as general improvements. For the improvements or purposes described in Section 2, there is hereby appropriated the sum of \$253,000 as required by the Local Bond Law. The total sum is now available by virtue of the existing Sewer Capital Improvement Fund balance.

**SECTION 2.**

The City hereby authorizes the appropriation of \$253,000 from the Sewer Capital Improvement Fund for the purpose of purchasing a new Roll-Off Truck and related equipment, such truck and equipment having a reasonably estimated useful life of at least five (5) years.

**SECTION 3.**

The purposes and improvements described in Section 2 of this ordinance are not current expenses. They are all improvements or purposes that the City may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

**SECTION 4.**

Any grant moneys received for the purposes described in Section 2 hereof shall be applied to the direct payment of the cost of the purposes or improvements.

**SECTION 5.**

The City hereby certifies that it has adopted a capital budget. The capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital budget, a revised capital budget will be filed with the Division of Local Government Services.

**SECTION 6.**

This ordinance shall take effect ten (10) days after the first publication thereof after final adoption by the law.


