

ORDINANCE NO. 39-2023

AN ORDINANCE AMENDING MILLVILLE CITY CODE, CHAPTER 5 ("ALCOHOLIC BEVERAGE CONTROL"), ARTICLE II. ("LICENSES"), SECTION 5-5. ("LICENSES and FEES")

WHEREAS, Code Section 5-5 ("Licenses and Fees"), A. 2. establishes the fee for plenary retail consumption licenses within the City of Millville; and

WHEREAS, Code Section 5-5 ("Licenses and Fees"), A. 3. establishes the fee for plenary retail distribution licenses within the City of Millville; and

WHEREAS, the Board of Commissioners finds that it to be in the best interest of the taxpayers of the city to establish a new fee schedule for the aforementioned licenses to keep up with the going rate which is statutorily established by the Department of Law, Division of Alcoholic Beverage Control; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF MILLVILLE that City Code Section 5 ("Alcoholic Beverage Control") and Code Section 5-5 ("Fees") are hereby amended to reflect the following fee schedule which will increase the increments by 10% per year until the statutory limits are reached for each license:

**Section One
Article II. Licenses**

§ 5-5 "Licenses and Fees"

A. No Change

(1) No Change

(2) Plenary retail consumption license. The holder of this license shall be entitled to sell any alcoholic beverages for consumption on the licensed premises, and also to sell any alcoholic beverages in the original containers for consumption off the licensed premises. No other mercantile business shall be operated on the premises. The annual fee for this license shall be as follows:

2026/2027 - \$1118

(3) Plenary retail distribution license. The holder of this license shall be permitted to sell any alcoholic beverages for consumption off the licensed premises, but only in original containers. No other mercantile business shall be operated on the premises. The annual fee for this license shall be as follows:

Section Two

Should any provisions of this ordinance be deemed invalid for any reason that invalidity shall not affect the remaining provisions of the ordinance, and the provisions and sections of the ordinance are hereby declared to be severable with respect to their validity.

Section Three

This ordinance shall take effect twenty (20) days after final passage, according to law.
