

**ORDINANCE NO.40 -2023**

**AN ORDINANCE AMENDING MILLVILLE CITY CODE, CHAPTER 2 ("ADMINISTRATION"), ARTICLE XIII. ("PUBLIC ACCESS TO GOVERNMENT RECORDS"), SECTION 2-50.4. ("PROCEDURES AND FEES FOR PURCHASING COPIES OF GOVERNMENT RECORDS")**

**WHEREAS**, Code Section 2-50.4 of Chapter 2, Article XIII of the City Code entitled ("Procedures and fees for purchasing copies of government records"), C. (1.) (a.) establishes the fee for certified copies of Birth Certificates: \$15 each; and

**WHEREAS**, Code Section 2-50.4 of Chapter 2, Article XIII of the City Code entitled ("Procedures and fees for purchasing copies of government records"), C. (1.) (b.) establishes the fee for certified copies of Marriage Certificates: \$15 each; and

**WHEREAS**, the Board of Commissioners finds it to be in the best interest of the taxpayers of the city to establish a new fee schedule for the aforementioned certified copies to keep up with the going rate which is \$20 each; and

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF MILLVILLE** that City Code Section 2-50.4 ("Procedures and fees for purchasing copies of government records"), C. (1.) (a.) and Code Section 2-50.4 "Procedures and fees for purchasing copies of government records"), C. (1.) (b.) are hereby amended to reflect the following:
