ORDINANCE NO: 2023-O1

## AN ORDINANCE OF THE BOROUGH OF MIFFLINBURG, UNION COUNTY, PENNSYLVANIA, VACATING A PORTION OF THE CUL-DESAC OF OAK AVENUE IN THE BOROUGH OF MIFFLINBURG, UNION COUNTY, PENNSYLVANIA

WHEREAS, in connection with the planned extension of Oak Avenue, Dave and Cindy Gutelius ("Gutelius") have requested the Borough of Mifflinburg ("Borough") vacate the remaining portion of the Oak Avenue cul-de-sac owned by the Borough to accommodate the extension of the cul-de-sac by Gutelius; and,

WHEREAS, Gutelius is the record owner of tracts of land situate along Oak Avenue located to the southwest of its intersection with North $8^{\text {th }}$ Street in the Borough of Mifflinburg ("Borough"); and,

WHEREAS, Oak Avenue extends southwest from its intersection with North $8^{\text {th }}$ Street and ends in a cul-de-sac circle;

WHEREAS, the Borough previously vacated a portion of Oak Avenue to Gutelius, leaving only the cul-de-sac circle in ownership of the Borough; and,

WHEREAS, the remaining portion of Oak Avenue ending in a cul-de-sac circle is unused by the public and is surrounded by lands owned by Gutelius; and,

WHEREAS, Gutelius has presented a final Land Development Plan (the "Plan") for the Oak Avenue Subdivision Extension to the Borough Planning Commission that requires the Borough to vacate the remaining portion of the cul-de-sac to accommodate the extension of Oak Avenue; and,

WHEREAS, conditional approval of the Plan by the Borough Planning Commission requires the Borough to vacate said remaming portion of the Oak Avenue cul-desac; and,

WHEREAS, the Borough Code in Section 1731, 8 Pa.C.S. § 1731, authorizes the Borough to vacate a street or portion thercof by ordinance if, after due notice to all property owners affected and advertisement in a newspaper of general crrculation, it is deemed prudent and advisable in the judgment of Borough Council to so vacate such strect or portion thereof; and,

WHEREAS, after advertisement in a newspaper of general circulation and due notice to all affected property owners, Borough Council of the Borough of Mifflinburg has determined that it is necessary and proper to vacate the heremafter described cul-de-sac of Oak Avenuc subject to the provisions of this Ordinance.

NOW, THEREFORE, be it, and it is hereby ORDAINED by the Borough Council of the Borough of Mifflinburg, and it is hereby ENACTED and ORDAINED by authority of same as follows:

## Section 1

The Borough of Mifflinburg, Union County, Pennsylvania, does hereby vacate all that certain tract of land compromising the cul-de-sac of Oak Avenuc, as shown in Exhibit "A", to accommodate the proposed extension of the Oak Avenue cul-de-sac by Gutelius, as depicted on Exhibit "B", which are both attached hereto and made a part hercof.

## Section 2

Upon the vacation and abandonment of the aforesaid cul-de-sac of Oak Avenue, title to the cul-de-sac so vacated shall revert to Gutclius as the owner of the abutting properties.

## Section 3

The President or Vice President of Borough Council and the Secretary or Assistant Secretary of the Borough are hereby authorized and empowered to execute any quitclaim deeds, deed of dedication, or releases which may be necessary or desurable in the opinion of the Borough to clarify and establish title to the aforesaid abutting owner of the right-of-way vacated and abandoned by this Ordinance.

## Section 4

In the event any provision, section, sentence, clause or part of this Ordinance is held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such mnvalidity, illegality, or unconstitutionality shall not affect or imparr the remaining provisions, sections, sentences, clauses, or parts of this Ordinance, it bemg the intent of Borough Council that the remainder of the Ordinance shall be and shall remain in full force and effect.

## Section 5

This Ordinance shall take effect and be in force from and after its enactment as provided by law.
