AN ORDINANCE REQUESTING PERMISSION TO SET THE PRICES FOR FIELD USAGE AT THE STADIUM AT MEMORIAL FIELD *ONLY FOR* SPORTS PRACTICES

WHEREAS, by letter dated March 15, 2023, the Commissioner of the Department of Recreation has requested legislation to request prices for practice and field usage for sports practices *ONLY* at The Stadium at Memorial Field. The information is as follows:

A Security Deposit of 50% of the total fee is due upon approval of your request. Full payment is due at least one (1) week prior to the requested activity date. Registered local Non-profit organizations and groups receive a 20% resident discount (Organizations must show proof that 75% of your participants/roster have valid Mount Vernon residency). The City of Mount Vernon, in City Council convened does hereby ordain and enact:

Section 1. The Department of Recreation is hereby authorized to set and list the prices for practice and field usage for sports practices *ONLY* at The Stadium at Memorial Field. The information is as shown in the bullet points above.

Section 2. These funds will be deposited into Revenue Code A2001.21 (Memorial Field Revenue). These funds will aid in reaching our projected budget goal of \$850,00.00 for Memorial Field.

Section 3. This ordinance shall take effect upon its approval by the Board of Estimate & Contract.
