

NOTICE

NOTICE IS GIVEN that the Council of the Borough of Muncy, in Lycoming County, Pennsylvania (the "Borough"), at a meeting of the Council to be held within not less than three (3) days nor more than thirty (30) days from the date of publication of this Notice, will consider for enactment an ordinance (the "Ordinance"), the caption and a summary of such proposed Ordinance being as follows:

"ORDINANCE NO. 530

INCURRING "LEASE RENTAL DEBT," AS DEFINED IN THE PENNSYLVANIA LOCAL GOVERNMENT UNIT DEBT ACT, IN THE MAXIMUM PRINCIPAL AMOUNT OF \$1,000,000, EVIDENCED BY THIS BOROUGH'S GUARANTY OF THE PAYMENTS DUE UNDER THE GUARANTEED WATER REVENUE NOTE, SERIES B OF 2015 TO BE ISSUED BY THE MUNCY BOROUGH MUNICIPAL AUTHORITY (MBMA) TO PROVIDE INTERIM FINANCING TO CONSTRUCT IMPROVEMENTS TO THE PUBLIC WATER SYSTEM FACILITIES OF MBMA, AND PAY RELATED EXPENSES; AUTHORIZING A GUARANTY AGREEMENT, BY AND AMONG THIS BOROUGH, AS GUARANTOR, MBMA, AND THE MUNCY BANK AND TRUST COMPANY, SECURING THE NOTE; PLEDGING THE FULL FAITH, CREDIT, AND TAXING POWER OF THIS BOROUGH IN SUPPORT OF ITS GUARANTY; APPOINTING A SINKING FUND DEPOSITORY IN CONNECTION WITH SUCH GUARANTY; AND AUTHORIZING RELATED ACTIONS AND DOCUMENTS."

The full text of the Ordinance (and a draft copy of the proposed Guaranty Agreement approved by the Ordinance) may be examined at the Muncy Borough Building, located at 14 North Washington Street, Muncy, Pennsylvania, on Monday through Wednesday between 8:00 A.M. and 3:00 P.M., Thursday between 8:00 A.M. and 6:00 P.M., and Friday by appointment by calling the Borough office at (570) 546-3952.

Amendments may be made to the Ordinance prior to its final enactment. An advertisement describing the final enactment of the Ordinance, including any amendments, will be made in accordance with the Pennsylvania Local Government Unit Debt Act (the "Debt Act"). Persons with disabilities may request auxiliary aids and services by calling the Borough office at (570) 546-3952.

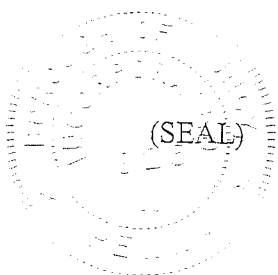



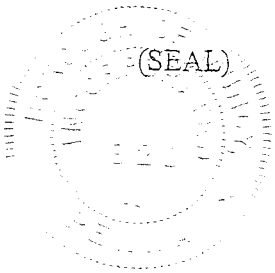
