

**BOROUGH OF NEW PROVIDENCE**  
**ORDINANCE 2022-16**

**“AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 257 OF THE  
CODE OF THE BOROUGH OF NEW PROVIDENCE ENTITLED ‘VEHICLES AND  
TRAFFIC’ “**

BE IT ORDAINED by the Mayor and Council of the Borough of New Providence,  
in the County of Union and State of New Jersey as follows:

Section 1. Article II, Section 15 of Chapter 257, entitled “Lane Use  
Reservations” shall be amended as follows:

The lane use locations described below are designed as lane use reservations  
and traffic shall move as indicated:

<b>Intersection</b>	<b>Movement</b>
Mountain Avenue and Glenside Road/South Street	A. Northbound left lane of Glenside Road reserved for left turn only. B. Southbound left lane of South Street reserved for left turn only.
Mountain Avenue and South Street/Glenside Road	A. Eastbound left lane of Mountain Avenue reserved for left turn only. B. Westbound left lane of Mountain Avenue reserved for left turn only.
Mountain Avenue and Union Avenue/Diamond Hill Road	A. Northbound right lane of Diamond Hill Road reserved for right turn only. B. Northbound left lane of Diamond Hill Road reserved for left turn only. C. Westbound left lane of Mountain Avenue reserved for left turn only.
Southgate Road and Mountain Avenue	A. Southbound left lane of Southgate Road reserved for left turn only. B. Southbound right lane of Southgate Road reserved for right turn only.

<p>Springfield Avenue and Maple Street</p>	<ul style="list-style-type: none"> <li>A. Eastbound right lane of Springfield Avenue reserved for right turns only.</li> <li>B. Westbound left lane of Springfield Avenue reserved for left turn only.</li> <li>C. Northbound left lane of Maple Street reserved for left turn only.</li> <li>D. Northbound right lane of Maple Street reserved for right turn only.</li> </ul>
<p>Springfield Avenue and South Street/Passaic Street</p>	<ul style="list-style-type: none"> <li>A. Westbound left lane of Springfield Avenue reserved for left turn only.</li> <li>B. Eastbound left lane of Springfield Avenue reserved for left turn only.</li> <li>C. Northbound left lane of South Street reserved for left turn only.</li> <li>D. Southbound left lane of Passaic Street reserved for left turn only.</li> </ul>
<p>South Street and High Street</p>	<ul style="list-style-type: none"> <li>A. Northbound left lane of South Street reserved for left turn only.</li> </ul>
<p>South Street and Central Avenue</p>	<ul style="list-style-type: none"> <li>A. Northbound left lane of South Street reserved for left turn only.</li> <li>B. Southbound left lane of South Street reserved for left turn only.</li> <li>C. Westbound left lane of Central Avenue reserved for left turn only.</li> <li>D. Eastbound left lane of Central Avenue reserved for left turn only.</li> </ul>
<p>Balcom Road and Central Avenue</p>	<ul style="list-style-type: none"> <li>A. Southbound left lane of Balcom Road reserved for left turn only.</li> <li>B. Southbound right lane of Balcom Road reserved for right turn only.</li> </ul>

Section 2. This Ordinance shall take effect twenty (20) days after final passage and publication in the manner as provided by law.
