ORDINANCE 2022-09

## "AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 257 OF THE CODE OF THE BOROUGH OF NEW PROVIDENCE ENTITLED 'VEHICLES AND TRAFFIC' "

BE IT ORDAINED by the Mayor and Council of the Borough of New Providence, in the County of Union and State of New Jersey as follows:

Section 1. Article II, Section 7 of Chapter 257, entitled "One-Way Streets" shall be amended as follows:

| Oakwood Drive   | North               | East Leg of Oakwood Drive Channelization at Intersection with Mountain Avenue    |

| Pioneer Drive   | West                | Entire Length  |
| Westerly Avenue | East                | Entire Length  |

Section 2. Article II, Section 8 of Chapter 257, entitled "Turn Prohibitions" shall be amended as follows:

No person shall make a turn of the kind prohibited (left, right, all) at any of the locations/intersections described in the list below:
