ORDINANCE OF THE BOROUGH OF NEW PROVIDENCE, IN THE COUNTY OF UNION, NEW JERSEY PROVIDING FOR **CANCELLATION** OF \$506,653.83 IN **BOND** NOT AUTHORIZATIONS AND/OR BOND PROCEEDS NEEDED FOR THEIR ORIGINAL PURPOSES AND TO TRANSFER \$482,467.58 IN BOND PROCEEDS TO THE SURPLUS FUND FOR **FUTURE CAPITAL** CAPITAL PROJECTS AND TO CANCEL \$24,186.25 IN BOND **AUTHORIZATIONS.**

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF NEW PROVIDENCE, IN THE COUNTY OF UNION, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that certain bond authorizations and/or bond proceeds in the aggregate amount of \$506,653.83 provided for in the various bond ordinances listed below are no longer needed for the purposes referenced therein. The Borough of New Providence, in the County of Union, New Jersey (the "Borough") desires, therefore, to cancel the following bond authorizations:

Section 2. The aggregate amount of \$24,186.25, which represents the unfunded debt authorization for the bond ordinances listed in the above-referenced chart, is hereby cancelled.

Section 3. The aggregate amount of \$482,467.58, which represents the funded debt authorizations for the bond ordinances listed in the above-referenced chart and made available pursuant to N.J.S.A. 40A:2-39, is hereby cancelled and transferred to the Capital Surplus Fund for future capital projects.

Section 4. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 5. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
