ORDINANCE NO. 2011-4

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 155 OF THE CODE OF THE BOROUGH OF NEW PROVIDENCE ENTITLED "FIRE PREVENTION"

BE IT ORDAINED by the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey as follows:

SECTION 1. Table 1 of Section §155-7-2 of the Code of the Borough of New Providence entitled "Non-Life Hazard Uses" is amended as follows:
