

**BOROUGH OF NEW PROVIDENCE**  
ORDINANCE 2016-03

**“AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 257 OF THE  
CODE OF THE BOROUGH OF NEW PROVIDENCE ENTITLED ‘VEHICLES AND  
TRAFFIC’”**

BE IT ORDAINED by the Mayor and Council of the Borough of New Providence, in the County of Union and State of New Jersey as follows:

Section 1. Article III, Section 23 of Chapter 257 entitled “Parking Prohibited at All Times, shall be amended as follows:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Southgate Road	East	<del>From the southerly curbline of Ryder Way extended to a point 340 feet northerly therefrom</del>
Southgate Road	North	From South Street to Foley Place
Southgate Road	West	From Foley Place to Ethan Drive
Southgate Road	West	<del>From Hathaway Drive to Ryder Way</del>

Section 2. Article III, Section 24 of Chapter 257, entitled “Stopping Or Standing Prohibited Certain Hours and Certain Streets” shall be amended as follows:

<b>Name of Street</b>	<b>Side</b>	<b>Hours</b>	<b>Location</b>
<del>Southgate Road</del>	<del>East</del>	<del>All, including Sundays and holidays</del>	<del>From the northerly curbline of Ethan Drive to the easterly side of the intersection with Foley Place</del>
Southgate Road	East	All	From Ryder Way to Mountain Avenue
Southgate Road	West	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m./Monday to Friday	<del>From Ryder Way to Mountain Avenue</del>

Section 3. Article III, Section 26 of Chapter 257, entitled "Parking Time Limited on Certain Streets" shall be amended as follows:

<b>Name of Street</b>	<b>Side</b>	<b>Time Limit; Hours/Days</b>	<b>Location</b>
Southgate Road	East	4 hours; 7:00 a.m. to 7:00 p.m./Monday to Friday	From a point 340 feet north of the southerly curblineline of Ryder Way extended to a point of 35 feet south of the southerly curblineline of Surrey Lane
Southgate Road	East	4 hours; 7:00 a.m. to 7:00 p.m./Monday to Friday	From Surrey Lane to Ethan Drive
Southgate Road	South	2 hours; 7:00 a.m. to 7:00 p.m./Monday to Friday	From a point at the easterly side of the intersection with Foley Place to South Street
Southgate Road	West	4 hours; 7:00 a.m. to 7:00 p.m./Monday to Friday	From Ethan Drive to Hathaway Drive
Southgate Road	East	2 hours or Railroad Parking Permit; All times, including Sundays and holidays.	From the northerly curblineline of Ethan Drive to a point 100 feet from the westerly side of the intersection with Foley Place.

Section 4. This Ordinance shall take effect twenty (20) days after final passage and publication in the manner as provided by law.
