

**BOROUGH OF NEW PROVIDENCE**  
ORDINANCE 2016-06

**“AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 257 OF THE  
CODE OF THE BOROUGH OF NEW PROVIDENCE ENTITLED ‘VEHICLES AND  
TRAFFIC’”**

BE IT ORDAINED by the Mayor and Council of the Borough of New Providence,  
in the County of Union and State of New Jersey as follows:

Section 1. Article II, Section 6 of Chapter 257, entitled “Speed Limits” shall be  
amended as follows:

No person shall drive a vehicle at a speed in excess of that indicated below, in the  
areas listed below. Speed limits are hereby established upon the following described  
streets or parts thereof

<b>Name of Street</b>	<b>Speed Limit (mph)</b>	<b>Location</b>
Central Avenue	40	<del>From the westerly New Providence Borough line to the center of South Street.</del>

Section 2. Article II, Section 10 of Chapter 257, entitled “Control of Movement  
and the Parking of Traffic on Public and Private Property” shall be amended as follows:

A. Municipal and Board of Education property.

- (2) Issuance of permits; expiration. The Borough Clerk is hereby authorized to issue  
to persons applying therefor, on payment of the required fees, permits for the  
parking of motor vehicles in the parking permit areas of the municipal public  
parking lots now or hereafter existing in the Borough of New Providence. Said  
permits shall be issued on an annual basis for a period of one year commencing  
April 1 of such year and terminating March 31 of the succeeding year and each  
permit shall authorize the person to whom it has been issued to park a  
designated motor vehicle in the permit parking areas provided in the municipal  
public parking lots during the hours when vehicles may be legally parked in said  
lots.

(3) Fee and application.

- (b) An applicant shall complete a form provided by the Borough Clerk, providing the applicant's name, address, license plate number, make, model and year of the car for which the applicant desires a parking permit. The Borough Clerk shall provide one parking decal with a permit number imprinted on it to the applicant. The permit is non-transferable. Any person who loses the decal and wished to obtain another, must pay a fee in accordance with Chapter 147, entitled "Fees and Licenses" of the Code of the Borough of New Providence.
  - (c) Any person to whom a permit has been issued may surrender such permit to the Borough Clerk and obtain a refund for each full month of the permit parking period remaining unexpired, provided that the person making said application shall pay to the Borough Clerk a refund fee of \$10 and shall, at the time of making said applicant, surrender the permit issued.
- (4) Sticker and display. At the time of the issuance of each permit, the Borough Clerk shall also issue to the person to whom the permit is granted a decal containing a preprinted permit number and the expiration date of said permit. Each such person to whom a parking permit is issued shall display same decal on the left bottom corner of the back (rear) window. Said parking permit must be kept visible at all times while parked in the municipal public parking lot.
- (5) Available times. During the hours between 5:00 a.m. and 2:00 a.m. of each day, except Saturdays, Sundays and federal holidays, it shall be unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or operated by such person to be parked in any permit parking area without a permit therefor or without the required decal affixed to said motor vehicle; provided, however, that any parking space equipped with a parking meter may be occupied by a motor vehicle not having attached to it a permit for such period as is permitted by operation of the meter, whether or not such parking space is included in the area in which parking by permit is permitted.
- (6) Meter parking. Motor vehicles are hereby permitted to be parked for one day only, during the hours in which vehicles may legally be parked as provided for herein on depositing the sum, in accordance with Chapter 147, entitled "Fees and Licenses" of the Code of the Borough of New Providence, in a meter if the same is provided or by payment of said sum in such other manner as may be established by the Mayor and Council.
- (8) Violations and penalties. Any person who may violate any provision of this subsection shall, upon conviction thereof, be punished by a fine not to exceed the sum of \$100 or by imprisonment for a period not exceeding five days.

Section 3. This Ordinance shall take effect twenty (20) days after final passage and publication in the manner as provided by law.
