

ORDINANCE NO. 2023-277

AN ORDINANCE OF THE BOROUGH OF NEW STANTON, COUNTY OF WESTMORELAND AND COMMONWEALTH OF PENNSYLVANIA, REPEALING, IN IT'S ENTIRETY, CHAPTER 6, ENTITLED CONDUCT, OF THE CODE OF ORDINANCES OF THE BOROUGH OF NEW STANTON.

WHEREAS, the Borough of New Stanton desires to repeal Chapter 6, entitled Conduct, in its entirety, §101 through §104, from the Code of Ordinances of the Borough of New Stanton.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Borough Council of the Borough of New Stanton, Westmoreland County, Pennsylvania, as follows:

SECTION 1. Chapter 6, §101 through §104, entitled Conduct, of the Code of Ordinances of the Borough of New Stanton, is hereby repealed in its entirety.

SECTION 2. SEVERABILITY. If any word, phrase, section, sentence, clause or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, invalidity or illegality shall not affect or impair any of the remaining words, phrases, sections, sentences, clauses or parts of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted had such unconstitutional, illegal or invalid word, phrase, section, sentence, clause or part thereof not been included therein.

SECTION 3. GENERAL REPEALER. Any ordinance or parts of ordinances in conflict with this Ordinance are hereby specifically repealed.

THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY.
