# CITY OF OCONTO FALLS ORDINANCE NO. 24-001

## AN ORDINANCE AMENDING ALDERMANIC DISTRICTS - CHAPTER 43-6 OF THE MUNICIPAL CODE AS FOLLOWS:

#### THE COMMON COUNCIL OF THE CITY DOES ORDAIN AS FOLLOWS:

#### SECTION 43-6 Wards

A.

. Ward One. Beginning at the intersection of South Main Street and County Trunk I; thence northwesterly along South Main Street to South Washington Street; thence northwesterly along South Washington Street to Poplar Avenue; thence easterly and north along Poplar Avenue to Wisconsin Street; thence easterly along Wisconsin Street to South Milwaukee Avenue; thence north along South Milwaukee Avenue and continuing along North Milwaukee Avenue to Grove Street; thence easterly on Grove Street to the easterly corporate limits of the City; thence south along the easterly corporate limits of the City to Columbia Street; thence easterly along Columbia Street to County Trunk I; thence south along County Trunk I to the place of beginning. Population: 392. (See Census block cell numbers below. [2])

Ward Two. Beginning at the intersection of South Main Street and South Washington Street; thence northwesterly along South Washington Street to Poplar Avenue; thence easterly and north along Poplar Avenue to Wisconsin Street; thence easterly along Wisconsin Street to South Milwaukee Avenue; thence north along South Milwaukee Avenue and continuing along North Milwaukee Avenue to Grove Street; thence easterly on Grove Street to the easterly corporate limits of the City; thence north and easterly along the easterly corporate limits of the City to County Trunk I; thence north on Country Trunk I to the northeasterly corporate limits of the City; thence in a counter clockwise direction along the north corporate limits of the City to North Chestnut Avenue; thence south along North Chestnut Avenue to Union Avenue; thence southwesterly along Union Avenue to South Franklin; thence northwesterly along South Franklin to Central Avenue; thence southwesterly along Central Avenue to South Main Street; thence southeasterly along South Main Street to the place of beginning. Population: 701. (See Census block cell numbers below.<sup>[3]</sup>)

C.

Beginning at the intersection of North Main Street and Central Avenue; thence northeasterly along Central Avenue to South Franklin Street; thence southeasterly along South Franklin Street to Union Avenue; thence northeasterly along Union Avenue to North Chestnut Avenue; thence north on Chestnut Avenue to the north corporate limits of the City; thence counter clockwise along the corporate limits of the City to County Trunk B; thence westerly and south along the corporate limits of the City to State Highway 22; thence southeasterly along State Highway 22 and North Main Street to the place of beginning. Population: 583. (See Census block cell numbers below.<sup>[4]</sup>)

D.

Ward Four. Beginning at the intersection of North Main Street and Central Avenue; thence northwesterly along North Main Street to the corporate limits of the City; thence westerly and south along the corporate limits of the City to the south shores of the Oconto River; thence southeasterly along the shores of the Oconto River to North Maple Avenue; thence southwesterly on North Maple Avenue to Pine Street; thence westerly along Pine Street to Water Street; thence northwesterly along Water Street to King Street; thence southwesterly and westerly along King Street to Elm Avenue; thence south along Elm Avenue to

Green Bay Avenue; thence easterly and northeasterly along Green Bay Avenue to the westerly shores of the Oconto River; thence northwesterly along the shores of the Oconto River to Central Avenue; thence northeasterly along Central Avenue to the place of beginning. Population: 367. (See Census block cell numbers below.<sup>[5]</sup>)

### E.

Ward Five. Beginning at the intersection of South Main Street and County Trunk I; thence northwesterly along South Main Street to Central Avenue; thence southwesterly along Central Avenue to the westerly shores of the Oconto River; thence southeasterly along the shores of the Oconto River to Green Bay Avenue; thence southwesterly and westerly along Green Bay Avenue to Elm Avenue; thence north along Elm Avenue to King Street; thence easterly and northeasterly along King Street to Water Street; thence southeasterly along Water Street to Pine Street; thence easterly on Pine Street to North Maple Avenue; thence north on North Maple Avenue to the westerly shores of the Oconto River; thence northwesterly along the shores of the Oconto River to the corporate limits of the City; thence counter clockwise along the corporate limits of the City to the place of beginning. Population: 914. (See Census block cell numbers below.<sup>[6]</sup>)
