

RESOLUTION NO. 03 14 2024A

A RESOLUTION AUTHORIZING AN AGREEMENT WITH JTL LANDSCAPING, LLC, PROVIDING FOR ROCK AND SAND HAULING SERVICES, IN AN AMOUNT NOT TO EXCEED \$31,000.00.

WHEREAS, the City of O'Fallon accepted a bid for rock and sand hauling services from JTL Landscaping, LLC, in 2022, which was renewed in 2023 and has an option for an additional renewal in 2024; and,

WHEREAS, City staff believes that renewing the contract with JTL Landscaping, LLC, for 2024 is the best option for the City; and

WHEREAS, by awarding the third year of the contract to JTL Landscaping, LLC, the cumulative total of the contract will reach \$86,500, requiring City Council approval; and

WHEREAS, City Staff recommends approval of this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF O'FALLON, MISSOURI, AS FOLLOWS:

SECTION 1: The City Council approves on behalf of the City an agreement with JTL Landscaping, LLC, for rock and sand hauling services at a 2024 cost not to exceed \$31,000, in substantial conformity with the terms shown on Exhibit A attached hereto and incorporated herein by this reference as if set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The City Administrator and other appropriate City officials are hereby authorized to execute the Agreement and such additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.

AGREEMENT

THIS AGREEMENT is made and entered into by and between the City of O'Fallon, Missouri (CITY) and JTL Landscaping (VENDOR). The parties agree as follows:

1. VENDOR agrees to provide the CITY with goods in accordance with City of O'Fallon Bid #22-035, Rock & Sand Hauling Services dated 03/16/2022. Said document(s) shall be incorporated into this agreement by reference.
2. The CITY, in accordance with the above referenced document, will pay VENDOR an amount not to exceed \$31,000.00 upon receipt of Services. This includes the purchase and delivery of Material.
 - Rock Hauling
3. VENDOR shall provide and bill for only those services associated with this purchase. No additional charges will be allowed without prior approval. All changes shall be identified and quantified on each invoice.
4. VENDOR is an independent contractor and nothing contained herein shall constitute or designate VENDOR or any of its agents or employees as agents or employees of the CITY.
5. VENDOR agrees, during the performance of this agreement that it will not discriminate against any employee of applicant for employment because of race, creed, color, age, sex, national origin, ancestry, religion or political opinion or affiliation.
6. VENDOR shall maintain during the life of this agreement and furnish to the CITY the appropriate Professional Liability, Commercial General Liability, and workers Compensation insurance certificates in amounts sufficient for standard practice for projects of this nature.
7. VENDOR agrees to indemnify the CITY, its' officials, and employees from any loss, damage, costs, charges or expenses to person or property by reason of any action or omission on the part of any person or company involved in this agreement.
