A RESOLUTION AUTHORIZING AN AGREEMENT WITH BLANK SLATE, LLC, PROVIDING FOR THE PRODUCTION OF ENTERTAINMENT FOR THE HERITAGE & FREEDOM FEST MAIN STAGE, IN AN AMOUNT NOT TO EXCEED \$465,500.00.

WHEREAS, the City of O'Fallon annually supports and funds the Heritage & Freedom Fest; and

WHEREAS, the City has completed the original agreement for service years 2021-2023 in accordance with bid 20-046; and

WHEREAS, City Staff recommends extending the contract with Blank Slate, LLC, to include the first optional year included in bid 20-046 to provide production services for the 2024 Heritage & Freedom Fest

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF O'FALLON, MISSOURI, AS FOLLOWS:

SECTION 1: The City Council approves on behalf of the City an agreement with Blank Slate, LLC. for Production Services at a cost not to exceed \$465,500, in substantial conformity with the terms shown on Exhibit A attached hereto and incorporated herein by this reference as if set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The City Administrator and other appropriate City officials are hereby authorized to execute the Agreement and such additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.
