## A RESOLUTION AUTHORIZING THE PURCHASE OF NINETEEN (19) ROCKET IOT IN-CAR VIDEO SYSTEM BUNDLE FROM UTILITY ASSOCIATES INC. FOR A TOTAL COST OF \$227,050.

WHEREAS, these are additional Police vehicles that require in-car video tracking capability. DR 9/10/21

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF O'FALLON, MISSOURI, AS FOLLOWS:

The City Council approves on behalf of the City an agreement with Utility Associates Inc. at a cost not to exceed \$227,050 in substantial conformity with the terms shown on Exhibits A attached hereto and incorporated herein by this reference as if set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The City Administrator and other appropriate City officials are hereby authorized to execute the Agreement and such additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.

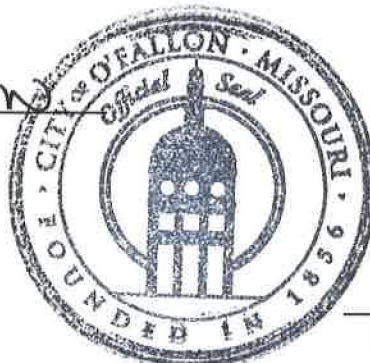
