

RESOLUTION NO. 04 11 2024E

A RESOLUTION AUTHORIZING A ONE-TIME PURCHASE OF ELEVEN (11) IN-CAR VIDEO SYSTEMS, INCLUDING FIVE (5) EOS CAMERAS AND MOUNTS, AND SPARE ACCESSORIES FROM UTILITY ASSOCIATES, INC., TO PROVIDE ADDITIONAL BODYWORN CAMERAS FOR NEW HIRES AND VEHICLE BUILDS FOR THE POLICE DEPARTMENT, IN AN AMOUNT NOT TO EXCEED \$71,297.78.

WHEREAS, the City of O'Fallon has budgeted for additional EOS Cameras and In-Car Video Systems; and

WHEREAS, the total expenses for the system including this additional purchase should not exceed \$297,171.01 this year; and

WHEREAS, City Staff recommends approval of this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF O'FALLON, MISSOURI, AS FOLLOWS:


SECTION 1: The City Council approves on behalf of the City an agreement with Utility Associates for eleven (11) In-Car Video Systems, including five (5) EOS Cameras and Mounts, and spare accessories at a cost not to exceed \$71,297.78, in substantial conformity with the terms shown on Exhibit A attached hereto and incorporated herein by this reference as if set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The City Administrator and other appropriate City officials are hereby authorized to execute the Agreement and such additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.


