ORDINANCE NO. 2021-16

AN ORDINANCE REGULATING SECURITY FOR GASOLINE SERVICE STATIONS

WHEREAS, the Borough Council is charged with the responsibility of public safety for the residences of the Borough; and

WHEREAS, the general public and residents of the Borough would benefit from a higher level of security which would be achieved by the installation of operational cameras at gasoline service stations; and

WHEREAS, the Borough believes that criminal activity can be avoided if sufficient security cameras are maintained at gasoline service stations within the Borough;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Penns Grove as follows:

- a. All gasoline service stations shall be required to install and maintain security cameras capable of obtaining footage of the consumer service areas, as well as every portion of the gasoline service station not located within the building or structure itself.
- b. The security cameras used in connection with this ordinance shall be capable of storing and maintaining all footage for a period of 180 days. After the passage of the 180 days from the foot was obtained, the gasoline service stations may delete the footage, unless otherwise instructed by law enforcement, in which case, the gasoline service stations must maintain the footage to the extent instructed by law enforcement.
