SECTION 2:

The rate of hourly employees shall be for the first eight (8) hours of work for each day and for all work in excess of (8) hours per day shall receive time and a half provided, however, that said employee have worked for (40) hours in said week. Extra time compensated for full time salary shall be compensated on any time worked between (35) to forty (40) hours. This does not apply to employees exempted under FLSA overtime standards.

SECTION 5:

Terms and conditions of employment for all positions recognized under a Collectively Bargained Agreement shall be in accordance with said agreement.

SECTION 6:

If any section, sentence, phrase or portion of this ordinance is for any reason invalid, such portion shall be considered separate and shall not affect the validity of the remaining ordinance.
