

**AN ORDINANCE AMENDING SECTION 85 OF THE CODE OF THE  
BOROUGH OF PENNS GROVE**

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Penns Grove, County of Salem, State of New Jersey, that Article V, Section 85-28 of the Borough code of Penns Grove entitled "Fees and Esrows" shall be amended as follows to delete the stricken portion and add the underlined portion:

**L. Application for zoning permit: \$25.00. If the zoning permit shall be in connection with a solar array, as set forth in Article XIII of Chapter 450, Zoning, of the Code of the Borough of Penns Grove, then the fee set forth in § 450-103C of the Code of the Borough of Penns Grove shall be applicable for a zoning permit.**



**SECTION 1:**

This Ordinance shall take effect immediately upon its final passage and publication as provided by law.




