AN ORDINANCE AMENDING ORDINANCE 198 – 6, ESTABLISHING FEES FOR BOROUGH ACTION TO REMEDY PROPERTY VIOLATIONS

WHEREAS, the Municipal Code of the Borough of Penns Grove chapter 198, section 6 allows for the Borough to enter onto private lands in order to maintain nuisance items including, but not limited to, trash, brush, weeds and plants and to impose a lien against the property owner for the Borough's remedial actions, and

WHEREAS, it is necessary to establish fees that the Borough can impose for remedial action to cure property violations,

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Penns Grove, County of Salem, State of New Jersey, that Chapter 198, Section 6, is hereby amended to add the following:

The following fee schedule shall apply to remedial action taken by the Borough to cure property violations:

Usage of Equipment

A.	Zero Turn Mower	\$100	per hour
B.	Trimmer/Weed Whacker	\$100	per hour
C.	Blower	\$75	per hour
D.	Lawn Mower	\$100	per hour
E.	Truck/Trailer	\$75	per hour

Labor Costs

A.	Board Up	\$150 per opening (includes materials)					
B.	Trash Removal	\$75 per 55 gallon bag					
C.	Edging/Trimming	\$200					

D. Grass Cutting

(50 X 100 Increments, 5000 Square Feet Minimum)

\$150 Moderate; \$250 Heavy overgrowth (12" +)

E. Administrative Processing Fee:

\$25

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon adoption and publication according to law.
