### ORDINANCE NO. 2023-11

#### AN ORDINANCE CONCERNING CANNABIS ZONING

NOW, THEREFORE, BE IT ORDAINED as follows:

#### SECTION I.

#### Licensing Permitted

Licensing for Cannabis shall be permitted in Zone M1 as follows:

Cannabis facilities in this Zone shall be limited to location in a maximum of two (2) structures.

Cannabis licenses in this Zone shall be limited to a maximum of five (5) licenses.

Cannabis license issued in this Zone shall be limited to Class 5 and Class 6 designations.

<u>SECTION 2</u>: All Ordinances of parts of Ordinances inconsistent with any of the terms of this Ordinance are hereby repealed to the extent of such inconsistency or inconsistencies.

**SECTION 3:** This Ordinance shall take effect immediately upon its final passage and publication, as provided by law.
