Councilperson MARTIN presents the following Ordinance:

**AN ORDINANCE AMENDING THE SALARY ORDINANCE OF  
THE BOROUGH OF PENNS GROVE**

**NOW THEREFORE, BE IT RESOLVED**, that the Borough Council hereby authorizes an amendment to the salary ordinance to increase the maximum salary for Borough Administrator from \$90,000 to \$95,000 per year, to set the stipend for Registrar, Board of Health at a range from \$3,174 to \$5,000 per year, and to creation positions of Laborer at the range from thirteen (\$13.00) to exceed fifteen dollars (\$15.00) per hour.
