

**AN ORDINANCE AMENDING SCHEDULE II OF THE CITY OF PEVELY  
MUNICIPAL CODE PERTAINING TO TABLE II-A PARKING PROHIBITED AT ALL  
TIMES**

WHEREAS, the Mayor and Board of Aldermen of the City of Pevely, Missouri wish to prohibit parking along certain streets within the City Limits; and

WHEREAS, the most appropriate way to prohibit parking along these certain streets is to add the names of the streets and locations to Table II-A which lists where parking is prohibited at all times.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PEVELY, MISSOURI, AS FOLLOWS:

Section 1. Table II-A of the City of Pevely, Missouri Municipal Code is hereby amended by adding the following language to the table as it currently exists:


Table II-A Parking Prohibited at All Times

Name of Street	Location
Eagle Crest	Both sides from Metropolitan Ave to the intersection of Eagle Crest, Fox Hollow, and Pheasant Drive
Eagle Crest	North side from the intersection of Eagle Crest, Fox Hollow, and Pheasant Drive and the entire cul-de-sac
Fox Hollow	South and east sides and entire cul-de-sac
Pheasant Drive	North and east sides and entire cul-de-sac
Deer Pointe	North side and entire cul-de-sac
Quail Meadow	North side and entire cul-de-sac

Section 2. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinctive, and independent provision and such holding shall not affect the validity of the remaining portions hereof.


Section 3. This ordinance shall be in full force and effect from and after the date of its passage and approval.


