# ORDINANCE OF THE CITY OF PLAINFIELD, IN THE COUNTY OF UNION, ADOPTING THE SOUTH AVENUE CORRIDOR REDEVELOPMENT PLAN AMENDMENT DATED DECEMBER 7, 2023

- WHEREAS, the City of Plainfield (the "City"), a public body corporate and politic of the State of New Jersey, is authorized pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq., as may be amended and supplemented (the "Redevelopment Law"), to determine whether certain parcels of land within the City constitute an area in need of rehabilitation or an area in need of redevelopment; and
- WHEREAS, on May 18, 2020, in accordance with the criteria set forth in the Redevelopment Law, the Plainfield City Council (the "City Council") adopted Resolution No. 177-20 designating certain property then identified on the tax maps of the City as Block 625, Lots 1 and 2 as an "area in need of redevelopment" (the "Redevelopment Area"); and
- **WHEREAS**, on August 10, 2020, by Ordinance No. MC 2020-15, the City Council adopted a redevelopment plan for the Redevelopment Area entitled "<u>South Avenue Corridor Redevelopment Plan</u>"); and
- **WHEREAS**, on November 13, 2023, the City Council adopted Resolution 416-23, designating Block 624, Lot 1 as a non-condemnation redevelopment area and directing the Planning Board to prepare an amendment to the Redevelopment Plan; and
- **WHEREAS**, the Planning Board caused Planning Consultant to prepare an amendment to the Redevelopment Plan to include Block 624, Lot 1, among other revisions, dated December 7, 2023 (the "**Plan Amendment**"), which was reviewed by the Planning Board on December 7, 2023 during a duly noticed public hearing; and
- **WHEREAS**, on December 7, 2023, the Planning Board adopted a resolution memorializing its findings, finding that the Plan Amendment is consistent with the City's Master Plan and recommending the adoption of the Plan Amendment; and
- **WHEREAS**, the City Council has reviewed the Plan Amendment and desires to adopt and implement the Plan Amendment in the form attached hereto as <u>Exhibit A</u>,
- **NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Plainfield, in the County of Union, New Jersey, as follows:
- Section 1. The aforementioned recitals are incorporated herein as though set forth at length.
- Section 2. The Plan Amendment as filed in the Office of the City Clerk, and attached hereto as Exhibit A, is hereby approved. The Plan Amendment supersedes the prior underlying zoning.
- Section 3. The zoning map of the City of Plainfield is hereby amended to incorporate the provisions of the Plan Amendment.
- Section 4. In case any one or more of the provisions of this Ordinance or the Plan Amendment shall, for any reason, be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Ordinance or the Plan Amendment, and this Ordinance shall be construed and enforced as if such illegal or invalid provision had not been contained herein.
  - Section 5. This Ordinance shall take effect as provided by law.
