## AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 16A, ARTICLE 1, SCHEDULE 1: NO PARKING ON THE EAST AND WEST SIDES OF ELAINE COURT TO WEST 7TH STREET.

**WHEREAS**, The City of Plainfield wishes to Amend the Ordinance language regarding No Parking on Elaine Court

**WHEREAS**, residents of the below street have reported parking concerns in the area

**WHEREAS**, the current language contained in the ordinance does not clearly address this concern

**WHEREAS**, after a review by the City of Plainfield Police Department Traffic Unit, this recommendation is being recommended as a means of improving traffic safety on Elaine Court and;

**NOW THEREFORE, BE IT ENACTED**, by the Municipal Council of the City of Plainfield, Union County, New Jersey, that the Vehicles and Traffic, Schedule 1 of Article 4, Section 16:4-2 Parking Prohibited at all times on certain streets, is hereby amended and supplemented as follows:


### Chapter 16A, Article 16A, Section 1-Schedule 1: No Parking

<u>Name of Street</u>	<u>Sides</u>	<u>SCHEDULE 1: NO PARKING</u>
16A. Elaine Court	East /West	To West 7 <sup>th</sup> Street

This Ordinance shall take effect after the final passage, twenty (20) days following action or inaction by the Mayor as provided by law, unless a resolution is adopted pursuant to N.J.S.A 40:69a181(b) declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
