# QUAKERTOWN BOROUGH Bucks County, Pennsylvania

### ORDINANCE # 1241

BOROUGH, BUCKS COUNTY, PENNSYLVANIA, AMENDING CHAPTER 18 OF THE QUAKERTOWN BOROUGH CODE AT SECTION 302 TO ALLOW FOR THE AMENDMENT OF TYPES AND AMOUNTS OF PROHIBITED DISCHARGE AS APPROVED BY THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY TO BE REVISED, FROM TIME TO TIME, BY RESOLUTION OF QUAKERTOWN BOROUGH COUNCIL AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, Quakertown Borough Council, under and pursuant to the Borough Charter and the Pennsylvania Borough Code, has the power to provide for wastewater collection and treatment; and

**WHEREAS**, the United States Environmental Protection Agency periodically revises the types and amounts of prohibited discharges to a sewage treatment facility; and

**WHEREAS,** Quakertown Borough Council deems it an efficient use of resources to allow for the regulation and amendment of prohibited discharges to be achieved by resolution of Council rather than by adoption of additional legislation.

**NOW THEREFORE IT IS HEREBY ORDAINED**, by the Quakertown Borough Council as follows:

## ARTICLE I SPECIFIC POLLUTANT LIMITATIONS

Chapter 18, Sewers and Sewage Disposal, Part 3, Wastewater Industrial Pretreatment Program, of the Quakertown Borough Code shall be amended by revising §302-3, Specific Pollutant Limitations to read as follows, with additional language provided in italics:

### Part 3 RIGHTS OF WAY MANAGEMENT

§302-3. **Specific Pollutant Limitations.** *By resolution of Borough Council*, the Borough may establish, and review from time to time, local limits regulating the discharge of specific pollutants by industrial users. Local limits developed to prevent pass through or interference or to implement prohibited discharge standards shall be approved by the approval authority.

The remainder of Part 3, including §18-302.3(A)—(F) remain unchanged and shall continue in full force and effect.

### ARTICLE II REPEALER

All Borough ordinances or parts of ordinances which are inconsistent herewith are hereby repealed but only to the extent of such conflict.

# ARTICLE III SEVERABILITY

If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid by any court of competent jurisdiction, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of Borough Council that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.

## ARTICLE IV EFFECTIVE DATE

This Ordinance shall become effective five (5) days after enactment.
