#### **ORDINANCE NO. 2023 - 591**

"Amendments to Traffic & Parking Regulations"

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF RED HILL, CHAPTER 15 (MOTOR VEHICLES AND TRAFFIC), PART 2 (TRAFFIC REGULATIONS), SECTION 15-207 (ONE-WAY STREETS ESTABLISHED) TO MAKE A PORTION OF TAGGART ALLEY ONE WAY AND AMENDING CHAPTER 15 (MOTOR VEHICLES AND TRAFFIC), PART 4 (GENERAL PARKING REGULATIONS), SECTION 15-403 (PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS), PARAGRAPH A TO PROHIBIT PARKING ON A PORTION OF WEST FOURTH STREET AND AMENDING CHAPTER 15 (MOTOR VEHICLES AND TRAFFIC), PART 4 (GENERAL PARKING REGULATIONS), SECTION 15-405 (PARKING OF TRUCKS, BUSES AND CERTAIN OTHER VEHICLES PROHIBITED IN CERTAIN LOCATIONS) PARAGRAPH A TO PROHIBIT FOOD TRUCKS AND MOTORIZED VENDING UNITS FROM PARKING ON STREETS AND ALLEYS.

The Borough Council of the Borough of Red Hill does hereby **ENACT** and **ORDAIN** as follows:

#### SECTION L. - Amendment to Code

The Code of Ordinances of the Borough of Red Hill, Chapter 15 (Motor Vehicles and Traffic) Part 2 (Traffic Regulations), Section 15-207 (One-way Streets Established) is hereby amended to (1) change the title of Section 15-207 from "One-way Streets Established" to "One-way Streets and Alleys Established" and (2) by deleting the existing subsection 1 and replacing it with a new subsection 1 as set forth below and adding Taggart Alley to the existing list as set forth below:

The following are established as one-way streets and alleys and it shall be unlawful for any
person to drive a vehicle on any one-way street other than in the direction established for traffic
on that street.

Street From To DIRECTION OF TRAVEL

Taggart Alley West 10<sup>th</sup> St West 11<sup>th</sup> Street North

#### SECTION II. - Amendment to Code

The Code of Ordinances of the Borough of Red Hill, Chapter 15 (Motor Vehicles and Traffic), Part 4 (General Parking Regulations), Section 15-403 (Parking Prohibited at All Times in Certain Locations), Paragraph A, is hereby amended to add the following parking prohibitions to the existing list:

STREET SIDE BETWEEN

Fourth Street, West South Main Street and Graber Alley

## SECTION III. - Amendment to Code

The Code of Ordinances of the Borough of Red Hill, Chapter 15 (Motor Vehicles and Traffic), Part 4 (General Parking Regulations), Section 15-405 (Parking of Trucks, Buses and Certain other vehicles prohibited in Certain Locations), Paragraph A, is hereby amended to add "food trucks" and "motorized vending units" to the list of vehicles prohibited in certain locations in the first sentence of Paragraph A.

## **SECTION IV. - Severability**

The provisions of this Ordinance are intended to be severable, and if any section, sentence, clause, part or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Council that this Ordinance would have been adopted even if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

## SECTION V. - Failure to enforce not a Waiver

The failure of the Borough to enforce any provision of this Ordinance shall not constitute a waiver by the Borough of its rights of future enforcement hereunder.

## SECTION VI. - Effective Date

This Ordinance shall take effect and be in force from and after its approval as required by the law.

# SECTION VII. - Repealer

All other ordinances and resolutions or parts thereof insofar as they are inconsistent with this Ordinance are hereby repealed.
